2. **Dress-code:** a suitable professional attire in-line with the skill participating, no transparent/revealing attire will be permitted. The participants must ensure proper dress code is followed by their respective models as well on whom they will be performing the specific skill module during the India Skill Competition.
3. **Footwear:** Sober- professional shoes covering the toes, comfortable, no heels allowed.
4. **Jewellery:** minimal, professional jewellery permitted.
5. **Make-up:** minimal professional make-up permissible.

7. **Hair:** Neatly tied n a bun, covered with net
8. **Hygiene & Grooming:** Well manicured nails, neat ears, clean-shaved/neatly trimmed beard/ moustaches.

#### INSTRUCTIONS TO THE COMPETITOR- Hair Modules

##### MODULE 1 – MEN'S MODERN CLASSIC

##### CATEGORY – JUNIORS

AGE OF COMPETITOR – Less than 21 years

DONE ON A - Live model

##### RATIONAL

- In this module the competitor needs to create a modern classic haircut & blow dry.
- Necklines & sides are traditionally tapered & graduated on a live model.
- Competitor will not create an OMC look.

##### HAIRCUT

- The neckline is tapered as close to zero.

##### STYLE

- The finished style cannot cover the face.

##### COLOR

- No colored hair crayons can be used.
- The entire hair needs to be of one color, natural dark brown, and black.
- No colored spray or glitter spray can be used.
- No colored mousse, gels and colored markers can be used.

##### STYLING PRODUCTS

- All styling products are allowed.

##### CUTTING TOOLS

- All cutting tools are allowed except for clipper & tweezers.
- Razor to clean the surface can be used only with shaving cream, foam or gel.

##### STYLING TOOLS

- Only hand held dryers must be used.
- No thermal irons are allowed.
- Brushes, combs & clips are permitted.

##### TIME

- 1 Hour 30 mins(5 additional minutes will be given to clean up the station).

##### PENALTY

- If the above rules are not followed.

##### COMPETITOR WILL BE PROVIDED

- Station Number (start of the competition)
- Model card (start of the competition)
- Capes (Before at the time of registration)
- Apron (Before at the time of registration)
- Rules (at the time of registration)
- Mirror & station to work on (on the competition floor)
- Plug points (on the competition floor)

##### NOTE

- The competitor needs to brush all the hair back before the start of the competition
- The hair can't be thinned prior to the competition.
- Competitor is allowed to use all brands of color, styling products
- Competitor has to bring their own styling tools, cutting tools, styling products
- The models make-up/clothes have to be pre-done before the competition.

##### MODULE 2 – LONG HAIR DOWN

##### CATEGORY – JUNIORS

AGE OF COMPETITOR – Less than 21 years

DONE ON A - Live model

##### RATIONAL

- The competitor needs to create a long hair open style that would grace magazine covers & the catwalks with a commercial color design.
- The competitor will not create an OMC look.
- The competitor creates the design & color based on a concept & idea.

##### HAIR EXTENSION

- No hair extensions are allowed.

#### HAIR SUPPORT

- No hair stuffing & support are allowed.

#### HAIR PIECES

- No pre-styled hair pieces are allowed.

#### COLOR

- The models hair need to be pre colored
- Spray colors & glitter spray are forbidden.
- Color Hair crayons and colored mascara is forbidden.
- Colored mousse, colored gels are forbidden.

#### STYLING PRODUCTS

- All styling products are allowed.

#### STYLING TOOLS

- All styling tools are acceptable.

#### STYLING CLIPS & TOOLS

- No Pins & clips and rubber bands are to be left in the hair once the hairstyle is completed & ready to be judged.

#### ORNAMENTS

- Ornaments & accessories are not allowed in the hair once the hairstyle is completed & ready to be judged.

#### TIME

- 1 hour 30 mins (5 additional minutes will be given to clean up the station).

#### PENALTY

- If the above rules are not followed.

#### COMPETITOR WILL BE PROVIDED

- Station Number (start of the competition)
- Model card (start of the competition)
- Capes (Before at the time of registration)
- Apron (Before at the time of registration)
- Rules (at the time of registration)
- Mirror & station to work on (on the competition floor)
- Plug points (on the competition floor)

#### NOTE

- Competitor can use all brands of styling products & brands.
- Competitor has to bring a picture or pictures or objects that inspired them to create the hair style
- The model has to have her make-up done before the competition.
- Competitor will use their own styling & cutting tools & their own styling products.

#### MODULE 3 – BRIDAL LONG HAIR

#### CATEGORY – JUNIORS

#### AGE OF COMPETITOR – Less than 21 years

#### DONE ON A - Live model

#### RATIONAL

- The competitor is required to create a fashionable bridal hairstyle on pre colored long hair in sync with the latest bridal trends the competitor has to accessorise the style.

#### HAIR CUT

- Cutting Hair on the competition floor is not allowed; just trimming the edges is allowed competitor is not allowed to cut the length.

#### HAIR LENGTH

- The hair must be shoulder length or longer, pre cut hair is acceptable.

#### COLOR

- Pre done color to complement a bridal hair style
- Sprays colors & glitter spray are forbidden.
- Colored hair crayons and hair mascaras are forbidden
- Colored mousse and gel are forbidden.

#### EXTENSIONS

- Hair extensions are forbidden.

#### STYLING PRODUCTS

- All styling products are allowed

#### STYLING TOOLS

- All styling tools are allowed

#### HAIR PIECES

- Pre styled hair pieces are forbidden.

#### HAIR STUFFING

- Hair stuffing is forbidden.

#### ORNAMENTS

- Ornaments are allowed, it should cover only 25% of the style. It should complement the style.

#### MAKE-UP & DRESS

- Done to complement the bridal look. No marks allotted to them.

#### TIME

- 1 Hour 30 mins (5 additional minutes will be given to clean up the station).

#### PENALTY

- If the above rules are not followed.



#### COMPETITOR WILL BE PROVIDED

- Station Number (start of the competition)
- Model card (start of the competition)
- Capes (Before at the time of registration)
- Apron (Before at the time of registration)
- Rules (at the time of registration)
- Mirror & station to work on (on the competition floor)
- Plug points (on the competition floor)

#### NOTE

- Competitor is allowed to use any brands of styling and color products.
- Make-up & Dress has to be done before the competition starts
- Competitor has to brush the hair back, competitor cannot come to the floor with pins, clips, roller on the hair
- The hair cannot be pre styled for e.g., crimped, curled before the competition starts.
- The competitor can not use scissors to cut hair but he/she can use scissors to trim the ends.
- The competitor has to bring their own styling products, cutting tools & styling tools.
